DECLARATION

Whereas it appears to the District Collector, **Vikarabad** that a total extent of **Acs.5-35 gts.**, of land is required in the Village **Rasoolpur, Yalal Mandal, Vikarabad District** for public purpose viz.Tandur Bye Pass Road from KM 0/0 to 12/0 in the **Vikarabad** District Collector having been satisfied that the lands specified in the schedule below have to be acquired for public purpose, after having heard the objections of the persons interested and after due enquiry as provided U/s 15 of the Act 30 of 2013 and that the Requiring Body viz., **Executive Engineer, (R & B) Division, Vikarabad** has deposited the amount in full towards the cost of acquisition of the lands, the

following Declaration is made under section 19 (1) of the Act 30 of 2013 (Central Act 30 of 2013).

DECLARATION

Under Section 19 (1) of the Act 30 of 2013 (Central Act 30 of 2013), the District Collector, **Vikarabad**, hereby, declares that the lands specified in the Schedule below and measuring **Acs.5-35 gts.**; be the same a little more or less, are needed for a public purpose, to wit for **Bye Pass Road from KM 0/0 to 12/0 in the Rasoolpur village of Yalal Mandal, Vikarabad District.**

The declaration is made after hearing of objections of persons interested and due enquiry as provide U/s 15 of the Act No-30/2013.

The number of families likely to be rehabilitated and resettled due to land acquisition is Nil for whom the Resettlement Area has been identified. The details of the Resettlement Area are as follows:

Mines of Coal, iron-stone, slate or other minerals lying under the said land or any particular portion of the said land, except such parts of the mines and minerals which may be required to be dug or removed or used during the construction phase of the project for the purpose of which the land is being acquired are not needed.

A Summary of the Rehabilitation and Resettlement Scheme is as follows:

In the present Acquisition, there are no PDFs whose livelihood is effected, no self employment units, Petty shops, Artisans, small traders are effected under Acquisition. There are no houses effected/ displacement of families. Hence entitlements under Schedule-II(1) of RFCTLARR Act 2013 do not apply to this case.

No Government buildings and other public common amenities are affected in the area under acquisition. Hence to provide Government. public amenities, infrastructure facilities in the resettlement area under R&R Scheme is not applicable to this case.

A plan of the lands is kept in the Office of the Land Acquisition Officer & Sub-Collector, Tandur Division and may be inspected on any working day during Office hours.
